

NOTICE OF OPEN CONSULTATION

OPEN CONSULTATION N°: 024/DAM/ARPCE/2025 FOR THE IMPLEMENTATION OF TRAINING PROGRAMS FOR THE STAFF OF THE REGULATION OF POST AND ELECTRONIC COMMUNICATIONS.

The Regulatory Authority of Post and Electronic Communications (ARPCE) is launching an open consultation for the implementation of training programs for its staff, divided into four (04) lots as follows:

Lot 01: Training on TEMS: Network Testing and Analysis Tools

Lot 02: Training on IPv6

Lot 03: ISO Training with Certification

Lot 04: English Language Training

A bidder may submit an offer for one or several lots.

The bidder must submit an offer covering all activities included in the selected lot

CONDITIONS OF PARTICIPATION:

This consultation is open to service providers, whether natural or legal persons, belonging to one of the following categories:

a) Public or private training and educational institutions holding valid accreditation delivered by the competent public institutions or authorities (Ministry of Vocational Training and Education, or Ministry of Higher Education and Scientific Research).

b) Consulting firms, telecommunications consulting offices, IT consulting and advisory offices, audit firms, providers specialized in secretarial and administrative assistance, evaluators and designers of training and consulting programs, and legal and tax consultancy firms.

c) For certified training included in Lot No. 03, bidders must hold accreditation or a partnership agreement with the organization that issues the certificates for the mentioned training programs.

All bidders must have completed at least one (01) service similar to the subject of the lot tendered, within the last five (05) years, duly proven by certificates of good performance or any other valid supporting documents.

To this end, bidders who fail to provide the required supporting documents for the above condition will have their offers rejected.

II. PLACE OF TERMS OF REFERENCE WITHDRAWAL

These terms of reference can be obtained and/or transmitted by any means. Interested candidates may collect the terms of reference for this consultation either directly or through duly authorized representatives, who must be provided with a power of attorney, at the address mentioned below:

III. DOCUMENTS TO BE PROVIDED:

Offers must include an “application file”, a “technical offer” and a “financial offer”, according to article 14 of the terms of reference.

The “application file”, “technical offer” and “financial offer”, to be drawn up without erasure or overwriting, must be put in separate and sealed envelopes, indicating the name of the company, the reference and purpose of the consultation and the mention “application file”; “technical offer”, “financial offer” depending on the case.

The three (03) envelopes listed above must be inserted in a single envelope, sealed and anonymous, with the following statement:

IV. DURATION OF BID’S PREPARATION:

The duration of bid’s preparation shall be **fifteen (15) calendar days** from the date of first release of this notice of open consultation on the Website of the ARPCE. If this date coincides with a public holiday or a day of rest, the duration of bid’s preparation will be extended to the next working day.

V. DEADLINE FOR SUBMISSION OF OFFERS:

The deadline for submission of offers is set for the last day of the offer preparation period, as indicated in Article 18 of these terms of reference.

If the last day falls on a public holiday or a day of rest, the date for submitting offers is extended until the next working day.

(Any offer received by the contracting service after the deadline for submitting offers will be rejected).

VII. OPENING OF ENVELOPES:

The opening of the bids containing the application file, the technical offer, and the financial offer will be carried out by the commission for opening folds and evaluating bids

It will take place on the day corresponding to the date of submission of offers, at 14:00, at the ARPCE headquarter. If this day coincides with a public holiday or day of rest, the opening of envelopes shall be on the next working day.

VIII. PERIOD OF BIDS VALIDITY

The bidders will remain committed by their bids for a period equal to the duration of bid's preparation, extended for three (03) months from date of submission of bids.

This deadline is extended by an additional month for the provisional awardee of the consultation.
